# **Product Review Request Form**

## Requesting Sample Product for Review

Athena Computer Power Corp provides sample products to members of the media and contributors of publications.

To request a review sample, please follow our product review procedures. We receive many requests weekly, and with your help, we can speed up the review request process. If you are a web site reviewer or publications contributor, ACPC will offer free products of up to US\$100.00<sup>1</sup> for each product after the review is published.

## **Request Review with Product**

**1.** Please complete the Product Review Form and e-mail/fax to us for approval.

2. Order a product from our website for which you are interested in writing a review.

3. Write, finish, and publish your review on this product. *Please be sure to identify ACPC as the supplier of the product.* 

**4.** E-mail us at info@athenapower.us with a link of the published review article. If the article is in printed publication, such as Newspaper or Magazine, please fax a copy of the article.

**5.** For each approved review, ACPC will issue a refund<sup>1</sup> of the purchased item for the reviewer.

## Request Review without Product

ACPC will ship the product(s) to the product reviewer at no charge if the website link rank<sup>2</sup> is under 10,000. Please email info@athenapower.us and include the Website URL so we can confirm the review process.

## Program Requirements / Details

**Length requirement:** The review must be at least 1 page of two single-spaced text in Microsoft word with font size 10, excluding the pictures.

Picture Requirement: At least three photos.

**Review time:** The publisher is allowed up to 30 days after placing the order to finish the project and submit a link to the published review to claim your credit. *If no article is published after 30 days of the review approval, the review project will be invalid and no credit will be issued.* 

**Web Content Requirement:** Personal sites (not intended as a product review site) and offensive sites review will be rejected. The review should not be plagiarized in any way, should be independent, and well written. The review article should be published on the selected site for at least 3 months, starting from the issuance of the credit. We may also request a copy of the review to be published on our site.

**Credit / Refund after review:** Maximum refund per product review is the **actual cost** of the product (not including tax and shipping); the maximum refund is US\$100.00, whichever is smaller. Refund will be issued within 7 days after the article is published and confirmed.

Program Cancellation: ACPC may change and cancel this program at any time without notice.
